A motion was made by Bremer, seconded by Ajvazi, to adopt the meeting agenda. Motion carried.



Present were President John Webb and Trustee Bernadette Starzyk, Cary Brandt, Leslie Bremer. Thomas Diehl appeared via teleconference.


Also present were Timothy McCumber, Village Administrator – Clerk – Treasurer, Richard Cross, Attorney, and Gary Hansen, Public Works Director.
